After the 1st run, there will be a course setting of the 2nd run, 20 minutes for the course inspection of the 2nd run without the skates and without a test run and start of the 2nd run by categories and the times from the 1st run.

Results: The results are given by the sum of the times from both runs

Awards: For the 1st-6th place, racers will be awarded with a diplomas, for the 1st-3rd place, racers will be awarded with a medal. Winner ceremony will take place approximately 30 minutes after the end of the 2nd run.

Protests: May be placed within 15 minutes after the finish of the last racer with the fee 50,- EUR.

Warning: In case of any issue, the result will be decided according to the WORLD SKATE IA Competition Rules Inline Alpine 2026, which are available at: www.worldskate-alpine.org. Racers must have inline skates with 3-5 wheels per one skate. Racer without the helmet and protectors will not be allowed to start. Underaged racers are taking part on their parents' responsibility. Loss of the start number is punished by 20,- EUR fee. Racers, trainers and spectators are taking part on their own responsibility. The organizer is not responsible for any injuries or other damages. Races are not World Ranking.
